



Parking subscriptions 2023

Residents' subscription

Residents can apply for a residents' subscription, allowing free unlimited parking in certain zones. We would like to sum up the conditions.

Who does this subscription apply to?

This subscription applies to residents, owners of a residential unit without domicile, owners of a holiday home where no domiciliation is possible.

What does it involve?

- exemption from paid parking in the orange and green zones
- unlimited parking time in the blue zone
- paid parking in the red zone
- a maximum of 4 subscriptions per address

Prices

The first subscription is free, the second costs € 40 and the third and fourth are € 120 each. Subscriptions are payable annually and an administrative fee of € 40 will be charged for any change to the current subscription.

How to apply?

From 2 May 2023, you can apply for your subscription from parking company Indigo/ Streeteo. You can do this through Streeteo's website or in person in their office.

When applying for a subscription, you must submit the following documents:

- identity card in the applicant's name
- the municipal tax assessment notice for owners of a residential unit without domicile and owners of a holiday home where no domiciliation is possible
- registration certificate part 1 in the applicant/owner's name and address or home address
- if company car or leased car: certificate from employer or leasing company that the applicant has a company car or leased car

Corporate subscription

Who does this subscription apply to?

Companies and traders in De Panne and Adinkerke.

What does it involve?

- exemption from paid parking in the orange and green zone
- unlimited parking time in the blue zone
- paid parking in the red zone
- multiple subscriptions possible

Prices

- € 120 / subscription / year
- A change to the current subscription will incur an administrative fee of € 40.

How to apply?

- · via parking company Streeteo's website
- physically in the office of parking company Streeteo

The employer applies for and submits the following documents:

- VAT number of the company
- registration certificate part 1 in the name of the company

Caregiver subscription

Who does this subscription apply to?

The healthcare provider subscription is intended for doctors and healthcare providers.

What does it involve?

- maximum 1 hour in the red zone with blue parking disc displayed
- · exemption from paid parking in the orange and green zone
- unlimited parking time in the blue zone
- · multiple subscriptions possible

- € 40 / subscription / year
- A change to the current subscription will incur an administrative fee of € 40.

How to apply?

- via parking company Streeteo's website
- physically in the office of parking company Streeteo

The employer applies for and submits the following documents:

Caregiver subscription intended for doctors and healthcare providers

- identity card in the applicant's name
- registration certificate part 1 in the applicant/owner's name and address or home address
- certificate from the order of doctors or NIHDI

Caregiver subscription intended for employed healthcare providers

- VAT number of the company
- registration certificate part 1 in the name of the company

Employee subscription

Who does this subscription apply to?

Employees of local companies and traders not resident in De Panne or Adinkerke.

What does it involve?

- exemption from paid parking in the green zone
- paid parking in the orange and red zone
- limited parking time in the blue zone
- multiple subscriptions possible

Prices

- € 40 / subscription / year
- to be paid by the employer
- A change to the current subscription will incur an administrative fee of € 40.

How to apply?

- · via parking company Streeteo's website
- physically in the office of parking company Streeteo

The company/trader applies for and submits the following documents:

- · identity card in the employee's name
- proof of address and employment contract of the employee
- vehicle registration certificate part 1 in the name of and/or address of the employee
- if company car or leased car: certificate from employer that the employee has this permanent company car at his/her disposal

Who does this subscription apply to?

For household help with service vouchers.

What does it involve?

- exemption from paid parking in the orange and green zone
- unlimited parking time in the blue zone
- paid parking in the red zone
- multiple subscriptions possible

Prices

- € 40 / subscription / year
- to be paid by the employer
- A change to the current subscription will incur an administrative fee of € 40.

How to apply?

- · via parking company Streeteo's website
- physically in the office of parking company Streeteo

The company/trader applies for and submits the following documents:

- VAT number of the company
- registration certificate part 1 in the name of the company
- work certificate service vouchers
